PLAINTIFFS' MOTION FOR DEFAULT BY THE CLERK AGAINST DEFENDANTS, CIELO CASTILLO HOLDINGS II, LLC, AND GORILLA EQUITY DEVELOPMENT, LLC

Plaintiffs, DHV Ventures, LLC, individually ("DHV"), DHV Ventures, LLC, derivatively on behalf of 12540 HWY LLC, d/b/a StorageMax Wichita ("12540"), and David Heil, individually ("Mr. Heil"), hereby move the Clerk to enter defaults against Defendants, Cielo Castillo Holdings, II, LLC, and Gorilla Equity Development, LLC (collectively, the "Minor Corporate Defendants"), and state as follows:

1. On May 23, 2025, Plaintiffs filed this matter.

2. On June 27, 2025, the Minor Corporate Defendants' then-counsel accepted service of process for all Defendants and, therein, agreed to file the Minor Corporate Defendants' response to the Complaint on or before July 29, 2025.

- 3. On July 28, 2025, the Minor Corporate Defendants' then-counsel filed an unopposed motion seeking additional time, through and to August 18, 2025, for the Minor Corporate Defendants to file their response to the Complaint.
- 4. On July 30, 2025, the Minor Corporate Defendants' then-counsel moved to withdraw their representation of all of the Defendants in this matter.
- 5. On August 22, 2025, the Court entered an order granting the Minor Corporate Defendants' then-counsel's Motion to Withdraw. Importantly, the order of withdrawal stated as follows:

"Defendants have thirty (30) days from the entry of this Order to retain substitute counsel; Otherwise, David Minor shall be deemed to be proceeding in a *pro se* capacity." The withdrawal order also stated that "[c]orporate entities may not represent themselves in Florida. Failure of the limited liability companies to retain counsel may result in the striking of their pleadings."

- 6. Here, the Minor Corporate Defendants have failed to retain counsel to represent them in this action.
- 7. That said, the Minor Corporate Defendants have not filed any pleadings and, as a result, there is nothing to strike.
- 8. Nevertheless, the Minor Corporate Defendants have failed to file or serve any paper as required by law.
 - 9. As a result, defaults should be entered against them.

WHEREFORE, Plaintiffs, DHV Ventures, LLC, individually, DHV Ventures, LLC, derivatively on behalf of 12540 HWY LLC, d/b/a StorageMax Wichita, and David Heil,

individually, respectfully request that the Court enter defaults against Defendants, Cielo Castillo
